With reference to your online application registered on the subject cited above and subsequent correspondence in the matter (if any), It is to inform that on perusal of the documents received the following deficiency/deficiencies has/have been noted in your application -

• **Other Deficiency**

1. According to the online application of the school, total Land area of the school campus is 3060 Sq. Meters. However, as per rule 3.3 of CBSE Affiliation Bye-Laws, 2018, minimum requirement of Land area for affiliation purpose is 6000 Sq. Meters. This needs to be complied.
2. The school is required to arrange Composite Science Lab, Maths Lab and Computer Science Lab according to CBSE Affiliation Bye-Laws, 2018.
3. The school is required to upload the copies of Certificate about health and sanitary conditions, drinking water and fire safety of the school has been obtained from the competent authorities of the area.
4. Books are to be increased in the Library as per rule 4.3 of CBSE Affiliation Bye-Laws, 2018.
5. The school is required to appoint more TGTs, PTI, Special Educator, Wellness Teacher, Art Teacher and Lab Assistants as per rules mentioned in Chapter-5 of CBSE Affiliation Bye-Laws, 2018.
6. No. of Computers are to be increased in the Computer Lab.
7. Disabled friendly washroom may be made available.
8. Pucca Boundary wall of sufficient height does not exist as per online form. hence may clarify.

Fulfillment of above conditions is mandatory. The application of the school cannot be processed any further.

The school is therefore directed to submit specific compliance on all the points mentioned above with supporting documentary and photographic evidence **within 30 days** of issuance of this letter. The compliances in response to the deficiencies are required to be submitted **ONLINE** only. Compliances/ Representations received after given time or offline (hard copies) will not be entertained.

All the documents (each page) must be signed by the Manager and Principal of the school and the same should be scanned and uploaded on the Board's website on the link [Compliance User Login](#).

The school may ensure that the documents to be submitted should be **scanned properly with the help of a scanner**. The PDF files prepared by clicking images with mobile phones generally result in illegible, hazy and dark documents which are not acceptable. The PDF files may have more than one page.

Please note that if the compliance report is not received within the specified time period, the application of the school will be rejected without further intimation.

It is further informed that school shall not start classes under CBSE pattern (IX/X/XI/XII as the case may be) without grant of affiliation by the Board, otherwise the Board will not be responsible for any consequences arising out of it.
